Call to Order – Dr. Ilene Wilkins, Chair

Allison Rudd called the meeting to order and completed Council member roll call. The presence of a quorum was established with all the members in attendance in person or via phone. The Council voted unanimously to approve the April 21, 2021, Meeting Minutes with no abstentions, or negative votes.

<u>State Office Update</u> – Dusty Edwards, Bureau Chief of Early Steps and Newborn Screening, Florida Department of Health

Dusty Edwards provided the council with a state office update. All contracts with the Local Early Steps (LES) were executed on time. Florida was allocated \$11.5 million in ARP funds. The program has been determining how and where the money can be spent within the regulations. The state has started the process to gain approval to spend the funds starting this fiscal year as well as next fiscal year. Renee Jenkins is retiring as Part C Administrator, and Jessica Meyer will take over as the new Part C Administrator. Dr. Ilene Wilkins asked where the ARP funds could potentially be spent. Jessica Meyer responded, there are several projects; a technical assistance provider to help with Child Outcome Summaries (COS) implementation, data system projects, a media campaign that will include an updated webpage as well as updated materials and training, quality improvement projects, provider retention projects and a full scale program evaluation to identify what the Early Steps State Office (ESSO) is doing well with and what can be improved upon. Some of the funding has not yet been earmarked. The funds are time limited. Dr. Ilene Wilkins requested that ESSO potentially set up some type of assisted technology were providers could request assessments and testing tools or receive a laptop. Rob Porcaro asked about the written clarification from the Office of Special Education Programs (OSEP) and the twentyseven-month window that funds need to be spent and more information regarding this. Jessica Meyer responded that the clock has already started regarding spending the funds. It began on July 1. ESSO has until September 2023 to obligate the funds. Rob Porcaro asked if ESSO has a time frame of when the projects will begin. Jessica Meyer responded that work has already started. ESSO is waiting on official approval from the Legislature to have the authority to spend the funds.

SSIP Update – Lily Wells, Government Operations Consultant III, Florida Department of Health

Lily Wells provided the council with an update regarding the State Systemic Improvement Plan (SSIP). This is federally mandated. Early Steps is implementing an evidence-based care giver coaching project at our LES sites. The project is intended to reform all Early Steps services to occur in the natural environment and providers coaching parents or other care givers to learn how to embed development interventions into their daily routine. 80% of our LES sites have started initial implementation. Three final sites will begin implementation next year.

Jessica Meyer informed the council that ESSO will not continue moving forward with the current vendor of the ESAS project.

Needs Assistance Determination - Jessica O. Meyer, MSW, Early Steps Program, Florida Department of Health

Jessica Meyer informed the council that ESSO received the grant determination letter from OSEP and Florida remains in the needs assistance category. ESSO has a renewed focus on improving compliance and child outcome summaries. The data system is critical to assist in monitoring. There are several quality improvement projects ESSO would like to work on. The determination is based on ESSO's indicators.
