Remarks – *Dr. Jeffrey P. Brosco, Deputy Secretary for Children’s Medical Services*

Dr. Jeffrey Brosco spoke about the emergence of value-based care, and the importance of measuring quality outcomes within the context of early intervention. Discussion ensued regarding how to encourage providers to embrace the coaching model concept.

Implementation Science – *Dr. Michelle Duda, Implementation Scientists, LLC*

Dr. Michelle Duda presented a high-level overview of Implementation Science, a tool that the Early Steps State Office (ESSO) has identified as a means to sustain effective system elements, ensure alignment of the system to the community level, and improve outcomes for all recipients of Early Steps services. The purpose of the presentation was to initiate discussion on how the Council’s input and recommendations can be sustained and integrated into the Early Steps system in a meaningful way.

The following components of Implementation Science were introduced:

- Active implementation frameworks
- Roadblocks
- Using a common language
- Fidelity
- Common challenges
- Usable intervention criteria

Council members participated in the ‘Glossary of Terms’ activity to pinpoint words or phrases that are pertinent to the Council and important to define for Early Steps stakeholders, e.g., families and caregivers.

Child Outcomes – *Dr. Batya Elbaum, University of Miami*

Dr. Batya Elbaum presented the Department of Education, Office of Special Education Program’s (OSEP) progress categories and Part C summary statements for child outcomes. The child outcome data in Florida, in addition to national data, were highlighted. Dr. Elbaum shared how the data were calculated using the OSEP progress categories, as applied to Florida’s Part C child outcome areas (social-emotional, language, and adaptive).

Discussion ensued on how other states that also use the Batelle Developmental Inventory, Second Edition to measure child outcomes compare to Florida, despite using different business rules.

State Systemic Improvement Plan (SSIP) Update – *Dr. Patricia Snyder, Dr. Juliann Woods, Institutes for Higher Education Team, SSIP Demonstration Sites, and Kimberly Porter, Early Steps State Office*

The Institutes of Higher Education Team (including Drs. Patricia Snyder, Brian Reichow, and Cinda Clark from University of Florida and Drs. Juliann Woods and Mollie Romano from Florida State University) led a follow-up presentation from the January 11, 2018, Council meeting on the Early Steps Professional Development (ESPD) project.

The following topics were covered:

- Purpose of the ESPD project
- Overview of EPIC (Embedded Practices in and Interventions with Caregivers) strategies, e.g. 5Q model and SOOPR
- Implementation manual and fidelity checklists for Lead Implementation Coaches and providers
- Provider home visiting practices
- Activities to date of the ESPD project
- Cohort 1 data

Feedback from the Lead Implementation Coaches, including Alex Stoerger from North Dade Early Steps, Chelsea Rojas from North Central Early Steps, and Reese Davis from Northeastern Early Steps, and from their respective Directors, was shared.

Discussion ensued on the following areas:

- Strategies utilized to overcome initial provider resistance within cohorts
- Cohort demographics and need to translate materials
- Assessment tool used at the demonstration sites
- Writing functional outcomes for the child and family that relate to social-emotional skills
- How providers use EPIC strategies within families and across different families
- Scale-up of EPIC practices across the state

FICCIT's Role in Program Improvement – *Dr. Michelle Duda, Implementation Scientists, LLC*

Dr. Duda facilitated a discussion with Council members to determine the core goals of the Council, and to re-center Council members to the purpose of the Council using the 'Elevator Pitch' activity.

The following areas were discussed or addressed throughout the activity:

- The need to understand ESSO's priorities so as to effectively offer advice
- How Council members may use their respective expertise to enhance Early Steps services
- Promote communication between ESSO and the Council, i.e. reciprocal information sharing
- How the Council can assist ESSO in overcoming barriers

The discussion ended with a first draft of the Council's elevator pitch.
