2017 Family Outcome Results – *Kelly Rogers, Early Steps Program Consultant, Florida Department of Health*

An overview of the 2017 family survey process and results was provided to the Council. A summary of the local family survey reports was provided that included the local and state response rate, indicator four results, local child demographic responses, and family survey item ranking.

Early Steps At-Risk Eligibility Category – *Renee Jenkins, Early Steps Program Administrator, Florida Department of Health*

A presentation on the Early Steps at-risk eligibility category was provided to the Council. The definition, as defined by 391.308, Florida Statutes, is a physical or mental condition known to create a risk of developmental delay. Conditions do not include environmental or socio-economic risk factors. Examples of at-risk conditions were provided to the Council, including birthweight between 1,200 to 1,500 grams, neonatal seizures, and Neonatal Abstinence Syndrome. Written confirmation of the at-risk condition is required from a licensed physician. Services for infants and toddlers with at-risk conditions, and their families, include: Individualized Family Support Planning, Service Coordination, Developmental Surveillance, and Family Support. A child with an at-risk condition will be moved to another eligibility category if there is documentation the child has a diagnosed condition with a high probability of developmental delay or a developmental delay that meets Florida's criteria as measured by appropriate diagnostic instruments and informed clinical opinion.
