Minutes

Call to Order — Misty Porter, FICCIT Chair

Misty Porter called the meeting to order at 10:01 a.m. ET and completed Council member roll call. An agenda overview was provided. The Council requested edits to the November meeting minutes and postponed voting to approve.

State Updates — Jessica Meyer, Part C Program Coordinator, Florida Department of Health

Jessica Meyer shared status updates of current and upcoming Early Steps State Office (ESSO) projects, including the Data System, Rate Study, and Program Evaluation. Jessica Meyer discussed the data requests from Council members and provided information. Council members requested additional data. State Office staff stated they will review the requests and bring the available data to the June meeting. Jessica Meyer proposed the idea of Council sub-committees. The Council discussed this possibility and requested more information on the vision and logistics prior to deciding. The Council requested time at the June meeting to further discuss sub-committees. The Council requested that it be noted in the minutes that the Council previously agreed to shorten the quarterly meeting in June to a one-day meeting held in Orlando to accommodate attendance at Family Café.

FICCIT Mission, Vision, Role Review — Andrea Gary, Division Director, Children's Medical Services, Florida Department of Health

Andrea Gary presented on the efforts and progress made by Council members and ESSO in the past year. She discussed the purpose of councils and how FICCIT can support ESSO efforts to serve children in Florida. Council members asked questions regarding public engagement at FICCIT meetings. Early Steps staff members provided additional information in response to Council member questions. Council members discussed the possibility of virtual or hybrid meeting options and the possibility of shortening the meeting length. ESSO staff stated they would determine what technological capabilities were available and provide an update at the June meeting.

Lunch

Council members took a break for lunch beginning at 11:58 a.m. The Council returned and resumed business at 1:31 p.m.

Florida Embedded Practices and Intervention with Caregivers (FL-EPIC)

Overview — Dr. Patricia Snyder, University of Florida

Dr. Patricia Snyder presented on the FL-EPIC model being implemented at Local Early Steps (LES) across the state. She explained that the FL-EPIC model is an evidence-based practice that trains Early Intervention (EI) providers to coach parents on ways to embed EI practices into daily routines, resulting in improved outcomes for children. Dr. Snyder discussed the history, current implementation,





and Sustainability and Scale Up (SuSu) plan. Council members asked questions about the presentation. Dr. Snyder and ESSO staff members provided additional information in response to Council member questions.

Break – The council took a brief break and resumed the meeting at 3:31 p.m.

FL-EPIC Provider Panel – Misty Porter, FICCIT Chair

Misty Porter introduced the panel format and facilitated the panel. The four panel members introduced themselves. The panelists included Jeremi Grosser, Paola Hatton-Negron, Reesi Guill, and Camille Velardo. Each panelist represented a Local Early Steps and supports FL-EPIC implementation at their site. Panelists discussed the benefits and challenges of scaling up FL-EPIC at their sites. Council members and panelists engaged in the question-and-answer session.

Closing and Next Day Logistics — *Misty Porter, FICCIT Chair*Misty Porter shared that the Council would reconvene for the second day of the meeting the next day at 9 a.m. in the same location.
