Minutes

Call to Order — *Misty Porter, FICCIT Chair*

Misty Porter called the meeting to order at 1:03 p.m. ET and completed Council member roll call. An agenda overview was provided. The Council reviewed the June meeting minutes. Monica Cantera-Serralta motioned to approve the minutes with no edits; Andrea Gary seconded the motion. The motion passed with no objection.

Voices from the Field — *Natalie Eno, Family Resource Specialist, Treasure Coast Early Steps*

Natalie Eno shared her family's experience with early intervention services. She discussed that Early Intervention had a positive impact for her family. Britt asked Natalie if her Local Early Steps (LES) program communicated with families via newsletter. Natalie stated that all LESs have been asked to pause sending newsletters to families at this time. Jessica Meyer clarified that the Early Steps State Office is developing a standardized template of communications for the local Early Steps Programs.

State Updates — *Jessica Meyer, Part C Program Coordinator, Florida Department of Health*

Jessica Meyer shared status updates of current and upcoming Early Steps State Office (ESSO) projects, including the clearinghouse fiscal services, Data System, Rate Study, Program Evaluation, Federal Grant and Determination Status, and Early Steps Extended Option. Jessica Meyer discussed the upcoming Council meetings and recommended that in 2026, the in-person Council meetings be held in February and August, with the May and November meetings being held virtually. The council accepted the recommendation with no objection. Britt Riner asked if the ESSO is considering providing music therapy as a covered service. Rob Porcaro stated that his LES has providers who are trained in music therapy and can provide this service. Jessica Meyer stated that there are several LESs that have this capacity and that while it is not implemented at a state level at this time, the state will explore it further.

Medicaid and Early Steps — *Ann Dalton, Assistant Deputy Secretary for Medicaid Policy and Quality, Florida Agency for Health Care Administration*

Ann Dalton presented on the federal and state implementation of Medicaid. Ann discussed the program funding, size, population, delivery systems, rate setting, and benefits. Rob Porcaro shared that providers at the local level have challenges with navigating billing with the Medicaid managed care plans. He stated that the number of denials for Medicaid payments makes provider retention difficult. Ann requested that he share additional information so that the Florida Agency for Health Care Administration (AHCA) can investigate issues and provide streamlined solutions.



Medicaid and Early Steps — Leila Jett, Data Analytics and Policy Unit Supervisor, Florida Department of Health

Leila Jett presented on collaboration between Medicaid and Early Steps, including services covered by Medicaid. She discussed the ongoing commitment from both AHCA and Early Steps to streamlining Early Steps services and addressing provider needs.

Misty Porter shared closing announcements.

Adjournment

Following the closing announcements, Andrea Gary motioned to adjourn the meeting for the day; Katrina Michel seconded the motion. The motion passed with no objection and the Council adjourned the meeting for the day at 3:05 p.m.
